# Continuing Through the Pandemic

**In-Church Worship Services, Activities and Events remain suspended until further notice.**

In order for us to continue to operate safely and within the CDC Guidelines as well as the DC government guidelines, we have had to put new practices in place.

**Schedule:** Since we can only have a limited number of **essential** individuals in the building at any one time, a schedule has been established. If you need to come to the church, a **24-hour notice is required**; you can simply contact the Office Staff either by email: [info@peopleschurchucc.org](mailto:info@peopleschurchucc.org) or by calling: 202-829-5511 and the staff will place you on the schedule.

1. **Accessing the building:** Strict procedures are in place which you will find posted at the front door (see below).

- Only one (1) person will be buzzed through the doors at a time.
- Each individual will have their temperature taken with a touchless thermometer.
- If an individual's temperature is above 100° they will not be allowed to remain in the building.
- Individuals **MUST** wear a mask at all times and use hand sanitizer.
- Individuals must sign-in and sign-out at the front desk.
- Individuals must maintain 6-foot of social distancing
